



## Texas Petroleum Marketers and Convenience Store Association YEAR 2010 FOUNDATION SCHOLARSHIP APPLICATION

The Texas Petroleum Marketers and Convenience Store Foundation (TPCA Foundation) will award a four-year, \$4,000.00 scholarship (\$1,000.00 annually) to five outstanding students in the state of Texas. This includes the TPCA WRANGLERS Associate Member Scholarship. Scholarships will be awarded to students graduating from accredited senior high schools within the state of Texas.

### **APPLICATION PROCEDURE**

Applications may be typewritten or printed by hand, must be completed in full, be accompanied by required documentation.

**Deadline:** The deadline for submission of the applications to be returned to the school for review will be set by the Individual participating school. However, all nominated applications to the Texas Petroleum Marketers and Convenience Store Foundation **must be received or postmarked no later than Friday, April 16, 2010.**

### **APPLICANT ELIGIBILITY**

To be eligible to apply for this scholarship, an applicant must meet criteria of citizenship, residence, academic standing, recommendation from his/her high school personnel (education) administrator, college/university enrollment plans, demonstration of leadership, character, citizenship and economic need.

The applicant must also be a dependent child of an active marketer, an active marketer's employee, or an active associate member of the Texas Petroleum Marketers and Convenience Store Association to apply to the Foundation for a scholarship award. Initial recipients shall be graduating high school seniors and each must be a United States citizen and qualify as a "dependent" of the member or the member's employee based on the rules in effect for federal income tax purposes.

**Citizenship:** Applicant must be a citizen of the United States or be born in the United States and be a resident of the State of Texas. If place of birth of applicant as indicated on application and/or transcript is other than the United States, appropriate proof of citizenship must be furnished with application.

**Residency:** The applicant must be a graduating senior or have been a qualified graduate of one of the accredited public/private senior high schools in the participating school district.

**Academic Standing:** The applicant must be a graduating high school senior ranked in the upper one-half (1/2) of his/her graduating class at the completion of his/her first semester of the senior year or at the time of the applicant's graduation. This ranking is to be verified as part of the official transcript or by an accompanying certification from an appropriate school official. Applicant's transcript must reflect that he/she has successfully passed the TAAS or equivalent replacement MASTERY/EXIT LEVEL exam at the time of application.

**Graduation:** The applicant must be eligible to attend an accredited college following the awarding of the scholarship or have been a mid-term graduate at the conclusion of the semester immediately preceding (within one year) the awarding of the scholarship.

**College Entrance Examination: No application will be accepted without SAT or ACT scores.** The applicant must have taken either the SAT or ACT college entrance examination and furnish proof of the test score and date(s) taken. Applicants must score a minimum of 900 on the SAT or a minimum score of 20 on the ACT in order to apply for the scholarship. These scores must be indicated on the application and verified either on the applicant's transcript or with a separate record of the scores that is attached. The highest score will be used for evaluation purposes, regardless of date taken. Applicants may not combine test scores from different test dates.

**Collegiate Acceptance/Enrollment:** The applicant must enroll or plan to enroll in either a college, university, or other recognized institution of higher education and participate in a curriculum leading to a bachelor's degree. Applicant must have applied for admission at time scholarship application is submitted if available at the time of application, a copy of the acceptance letter for enrollment should be included with the application. Applicant must indicate choice of major and career planned.

**Activities:** Leadership potential and character of the applicant should be demonstrated through an applicant's responses to the categories of the application detailing school, extracurricular and community activities and achievements. Personal references will provide additional information as well.

**Narrative:** Each applicant must include a typed or handwritten narrative of no more than two, 8 ½" x 11" sheets, double-spaced. In this narrative, the applicant may supply any information that he/she feels is pertinent to the application receiving proper consideration. Applicant's name, address and high school must appear as a heading to the narrative in the upper right hand corner of page one.

**Photo:** Each applicant must furnish a recent bust photograph, no smaller than 2" x 3". Picture should be enclosed in an envelope that is attached to the application. Do not staple or tape the photo directly to the application. Do not send Polaroid, instant photos or color photocopies of photographs. Photo should be identified with applicant's name typed on a label affixed to photo or written on back in soft pencil.

**References:** Each applicant may submit up to three (3) letters of personal reference. References may be either typed or handwritten and should include the name, address and daytime phone number of the person making the recommendation, as well as an indication of the person's relationship to the applicant (teacher, minister, employer, relative, etc.) These letters must be attached to the application. References should indicate knowledge of applicant's character, determination to pursue a college education and any other factors that will assist evaluation. No more than three letters may be submitted per applicant and no letter should exceed two pages in length.

**Documentation:** Each application must be accompanied by an official transcript showing academic average and grading scale through four years of high school, class size and official ranking of applicant; proof of either SAT or ACT scores; proof that applicant has passed the TAAS MASTERY/EXIT LEVEL exam; narrative; photo; references; proof of citizenship. If the transcript does not list the school's grading scale, a letter with this information must be included from the registrar or counselor.

**Deadline: All nominated applications to the Texas Petroleum Marketers and Convenience Store Foundation must be received or postmarked no later than Friday, April 16, 2010.**

**The Texas Petroleum Marketers and Convenience Store Foundation will not accept applications directly from students. Please mail your application.**

Applications should be stapled together only. Do not bind. Do not put in sheet protectors. Applications will not be returned and become the property of the Texas Petroleum Marketers and Convenience Store Foundation.

### **EVALUATION PROCEDURE**

For the purposes of evaluation of applicants, a selection committee independent of the TPCA Foundation will review all properly completed applications. Incomplete applications will not be considered. A rating sheet will be used as part of the evaluation process, with each application scored individually on the basis of the criteria outlined in the eligibility section.

The recommendations of the evaluation committee will be referred to the Texas Petroleum Marketers and Convenience Store Scholarship Foundation.

### **NOTIFICATION OF RECIPIENTS**

Recipients of scholarship awards will be notified individually by the Texas Petroleum Marketers and Convenience Store Association Scholarship Foundation. The TPCA Scholarship Foundation will also notify the central administrative office of each participating school district of the names of the recipients of the scholarships.

Notification will be made prior to the completion of the Spring semester in which the scholarship is to be awarded. The scholarship will be presented at the Texas Petroleum Marketers and Convenience Store Annual Convention held in July 2010.

### **PAYMENT OF STIPEND**

It is the responsibility of each scholarship recipient to notify the Texas Petroleum Marketers and Convenience Store Association Scholarship Foundation within 30 days of the beginning of school of the address of the Financial Aid Office and/or Scholarship Office of the college/university that the recipient will attend in the fall semester. Payment of the scholarship will be made directly to the Financial Aid Office at the rate of \$500.00 per semester in which the recipient is enrolled for 12 or more semester hours and is in good standing academically.

To maintain eligibility, the recipient must comply with all scholarship policies of the Texas Petroleum Marketers and Convenience Store Scholarship Association Foundation. A copy of these policies will be furnished to each recipient upon notification of receiving the award.
